The North Frog Hollow Neighborhood Revitalization Zone Committee held an adjourned regular meeting on Monday, June 2, 2008, at 5:00 PM at the home of the chair, 16 Columbia Street. The chair, David Corrigan, was present. The meeting had been originally scheduled for Thursday, May 22, 2008, but the chair postponed the meeting on two separate occasions due to exigent circumstances.

Mr. Corrigan called the meeting to order at 5:00 PM, and he certified that ballots were received from the following members: Joe Barber; Chris Brown; Luis Cabán; David Carrier; David Corrigan; Barry Lubin; Bob Painter; Doug Campbell; the Center for Community at Billings Forge, as represented by Liz Buczynski; Hartford Preservation Alliance, as represented by Tom Nenortas; Immaculate Conception Shelter and Housing Corporation, as represented by Patti White; Southside Institutions Neighborhood Alliance, as represented by John Bailey; and the City of Hartford, as represented by Patrick Campbell. Mr. Corrigan further certified that the number of ballots received was sufficient under the rules of the Committee for the vote to be valid. Mr. Corrigan further certified that twelve secret ballots had been returned in the election of Doug Campbell for Vice Chair of the Committee, and he noted that the number of secret ballots returned was sufficient under the rules of the Committee for the vote to be valid.

On the first item on the ballot, that the Committee approves the minutes for the April 2008 public hearing, the Committee voted to approve unanimously. Mr. Corrigan noted that the ballot erroneously referred to the “May 2008 public hearing,” but he noted that the context made it sufficiently clear that the April 2008 public hearing had been intended. The item was approved.

On the second item on the ballot, that the Committee approves the minutes for the April 2008 regular meeting, the Committee voted to approve unanimously. Mr. Corrigan noted that the ballot erroneously referred to the “May 2008 regular meeting,” but he noted that the context made it sufficiently clear that the April 2008 regular meeting had been intended. The item was approved.

On the third item on the ballot, that the Committee ratifies the letter sent in support of full funding for the Hartford Public Library under the fiscal year 2008-2009 municipal budget as changed, the Committee voted to ratify unanimously. The item was approved.

On the fourth item on the ballot, that the Committee re-authorizes the ad hoc subcommittee on the future use of 560 Park Street, the Committee voted to re-authorize unanimously. The item was approved.


